Requirements:

You must be a currently active member of a Carroll County 4-H Club or FFA group, and for the past 2 years you must have completed:

- For 4H, at least one project each year by exhibiting your project at the fair.
- For FFA, an SAE (or record book).

You must be a recent high school graduate enrolling or actively enrolled in a post-secondary institution. It does not have to be a 4-year college – trade schools and junior colleges are included.

Payment will be issued upon receipt of a class schedule or other proof of enrollment.

Please attach a 2-page (double spaced, 1" margins) essay on ONE of the following:

- How 4-H or FFA has impacted your life and has led you in the direction of your proposed field of study.
- Describe the 4-H or FFA service learning project that impacted you the most and why.
- Describe what it means to be a youth involved in the field of agriculture, especially in today's challenging conditions.
